

## END USER LICENSE TERMS FOR FONTS

### 1. INTRODUCTION

- 1.1. Terms. Please read these end user license terms for fonts ("**Terms**") carefully before You start using the **Products** (Our fonts). When You download, install, start using the Products or purchase a License to the Products from Paddle Platform, You, at the same time, conclude a license agreement with Us. If You do not agree to these Terms, You must not use the Products.
- 1.2. Economic sanctions. The Products are offered to users who are not a target of any sanctions regime, and do not reside in, nor will use the Products from a country from which such use is prohibited under any applicable sanctions regime or export control laws. By using the Products, You represent that You meet all of the foregoing requirements. If You do not meet these requirements, You must not use the Products. We reserve the right to limit the availability of the Product to any person, entity, area, or jurisdiction at any time.
- 1.3. Definitions. The terms with capital letters have the following meaning:

**"Product/s"** are fonts We created / hold rights to and to which We offer License on Our websites <https://oomtype.com>. You may purchase license from the Paddle Platform.

**"License"** is non-exclusive authorization to use the Products under the scope and limits set by the Terms. We offer various types of Licenses.

**"You"** are the person with whom We conclude the license agreement.

**"Authorized User"** is Your employee or representative (i.e. member of Your corporate bodies such as managing director) to whom You made the Product available for use on the basis of Your License under these Terms. The Authorized User shall not be Your External Contractor or Your supplier, customer, client etc. – i.e. they need a specific License/Sublicense (as laid down in clause 4.4. d) to be able to use the Product.

**"External Contractor"** is an entrepreneur/company who needs to use the Products to perform services for You (typically a graphic designer or agency who design logo and visual identity for You) on the basis of a contract (whether written or non-written) with You, or similar cooperation with a third person who is not directly employed by You / is not your representative.

**"We"** are the provider of the Products: Vojtěch Kollert (OoM Type), with registered office at Žďár nad Metují 1, ZIP code 549 55, Czech Republic, Entrepreneur ID No. 03615812, contact e-mail: [oomtype@gmail.com](mailto:oomtype@gmail.com).

**"Paddle Platform"** is the platform Paddle available from [www.paddle.com](http://www.paddle.com). This platform is our partner who ensures the sale of the License to our Product to You – they are resellers of the Licence. Paddle Platform is provided by Paddle.com Market Ltd., with registered office at Judd House, 18-29 Mora Street, London, United Kingdom, and its affiliated companies (Paddle Payments Ltd., Paddle.com Inc), from whom You purchase License to Our Products.

**“Your Materials”** are the outputs You or Authorized Users create with the use of the Products.

## **2. SUBJECT OF THE TERMS**

- 2.1. Role of Paddle Platform. We are offering Products (i.e. fonts) on our websites to You. If You wish to use the Products, You shall purchase a License in a sufficient scope for Your use of the Product. We want to offer the Products worldwide, but We are not able to sell the License to You directly (as You can imagine, We are graphic designers and We do not wish to spend our time on dealing with all tax duties and other administration on Our own). Therefore, We authorize Paddle Platform to be Our reseller. Once You select the desired Product and appropriate License (the calculator on Our website will calculate the price for You) and proceed to purchase, You will be redirected from Our website to Paddle Platform, and You will purchase the License to the Products directly from the Paddle Platform. Therefore, You confirm terms and conditions of Paddle Platform, make a payment towards Paddle Platform, get the link to download the Product from Paddle Platform and thus get the License from Paddle Platform – i.e. You have a direct relationship with Paddle Platform governed by terms and conditions of the Paddle Platform. The terms and conditions of the Paddle Platform are available from <https://www.paddle.com/legal/terms>.
- 2.2. Role of these Terms. The Paddle Platform does not govern the scope of License which You purchase via Paddle Platform – in other words, they do not set the rules for use of our Products, nor the consequences of their breach. Because the Products are Our intellectual property / We hold rights to them, We set the scope of License and rules of use of the Products herein, and We reserve Our rights to suspend / terminate Your License in case these Terms are breached. Important to say, We are not in direct relation with You in connection with any payment issues, refund requests, technical or issues with link / downloading the Product, consumer rights to cancel agreement, consumer rights to provision of digital content etc., those are Paddle Platform responsibility and You shall contact Paddle Platform directly in case such issues arise.

## **3. TECHNICAL SPECIFICATIONS**

- 3.1. File formats. The Product will be made available to You by Paddle Platform for download in electronic files in OTF format for Desktop, WOFF and WOFF 2 format for website. Therefore, the Product shall be used in software which supports formats OTF, WOFF, WOFF 2. We do not guarantee it will work well in software which does not support those formats.

## **4. LICENSE**

- 4.1. Grant and scope of the License. Upon full payment of the price of the Product and compliance with all requirements of Paddle Platform, Paddle Platform shall grant You **non-exclusive License** for use of the Product within unlimited territory and within unlimited time. However, there are following limitations of Your License to use of the Product, all of which depend on the particular **type of License** You selected and purchased. To warn You, using the Product beyond those limitations establishes breach of the License. Limitations for various types of License are:

- a) **purposes of use** of the Product, i.e. You are entitled to use the Product only for purposes to which You purchased License, i.e. to create only certain types of Your Materials / and to use them only in allowed manner. Within these methods and purposes of use, there is no limitation upon volume of the use (unless stated otherwise below) – e.g. if You have License for Social Media, You can use the Product for as many social media You want.
- b) **the number of Authorized Users** to whom You may provide the License. You can extend the Licence for additional Authorized Users by purchasing Extension License (but in case of decrease no refunds are applicable) as defined in section 4.2.
- c) **the size of Your company.** For some types of License, the price is calculated on the basis of the size of Your company – the bigger Your company is, the higher is the price. That's why You can use the Product only as long as Your company **has a maximum number of workers for which You selected the License** (this number includes all full time and part time employees and contractors which work for You for more than 20 hours a week). Once Your company grows bigger than that, the license terminates within 3 months from the beginning of the month following the month in which the number was exceeded (i.e. if the change in number happened on 12. 4. 2023, the 3 months period runs from 1. 5. 2023). If You do not extend Your License for increased number of workers, Your right to use the Products in Your Materials already created or published before the enlargement of Your company terminates (for example, You have to stop using the Product and You have to e.g. delete the posts on social media in which the Product appears, that were published before).

You can “extend” the license (in fact, purchase a new one because the old one terminated) by purchasing Extension License for additional number of workers. This does not go the other way around, i.e. if Your company gets smaller (or gets back to original number of workers), the price will stay the same (no refunds are applicable).

4.2. Types of the License. You may select and purchase the following types of License:

Remember, You are not allowed to grant Sublicense to Your customer, client or any other third person except for External Contractor - such persons have to purchase suitable License themselves! 4.3. Scope of use of the Products and Your Materials. You **can reproduce** (use a copy of) the Product to create Your Materials within the scope of methods of use and purposes allowed by the

purchased type of the License. You can **distribute, display, rent, loan or communicate Products as an integral part of Your Materials to the public or otherwise use them** also within the scope of the methods and purposes allowed by the purchased type of the License. However, You **shall not** reproduce nor otherwise use the Products:

- a) for any kind of content which violates any applicable laws or regulations,
- b) for content that promotes violence or discrimination,
- c) for a non-fungible token (NFT) without Our prior written permission to do so.

4.4. Prohibited actions. You further **shall not**, without Our prior written permission:

- a) rent, lease, lend the Products as such to a third person,
- b) distribute or communicate the source files of the Product – i.e. Your Materials shall be protected in a way that it is impossible to extract the Product from them, i.e. no one can reproduce and use the Product as such. In other words, You shall not embed the Product in a way that end users can access it (e.g. the font / other product and files with the font shall not be downloadable). Your Materials which use the Product shall be exported in non-editable raster image/other non-editable file,
- c) assign the License to a third person – i.e. transfer (for free or for a fee) Your authorization to use the Product to a third person (this does not preclude You from providing Your Materials to third parties),
- d) grant sublicense to a third person – i.e. allow third person to use the Product while You keep the License – other than Authorized User within the allowed limit if applicable (i.e. Your employees and representatives, but **not Your External Contractors or customers, nor Your affiliated companies!**) – unless You **purchased a Sublicense for External Contractor**. In case You provide the External Contractor with Sublicense, You **shall conclude an agreement in writing with him/her**, to bind him/her **by rules of these Terms**. You are liable for all breaches of this agreement caused by any person to which You or such person made the Product available. **If You are a graphical designer yourself and You need to provide the Product to Your customer/other third person** (except for External Contractor), **it is Your customer/third person who shall purchase the appropriate License directly!**
- e) modify, make derivative works (new fonts etc.) based on the Product, convert the Product to different formats, reverse engineer, decompile, disassemble the Product (You will not receive Product in source formats unless We conclude a separate agreement), except as expressly allowed under Logo and Tagline License.
- f) remove any proprietary notices (e.g. copyright notice) from the Product source files,

- g) use the Products in a manner or for any purpose that infringes, misappropriates, or otherwise violates any intellectual property right or other right of any person, or that violates any applicable law.
- 4.5. Immediate termination. Breach of this Article also represents material breach of the Terms for which We can immediately terminate the License, i.e. Your right to use the Product, without any refund.
- 4.6. Reservation of Rights. You agree that You have the rights expressly set forth in these Terms and no other. All rights not expressly granted in the Terms are reserved to Us.
- 4.7. Ownership. You acknowledge that We own all right, title and interest, including all intellectual property rights, in and to the Products.
- 4.8. Information, Records, Audit and Assistance. We may request information concerning use of the Products by You / Authorized Users / third persons to whom You made the Products available. You agree to provide us with requested information in writing within 3 days as of receipt of Our request. You shall also keep records of Your use of the Products. We may request, on reasonable prior notice, inspect and audit Your records. In case We reveal any deficiency (e.g. underpayment due to insufficient Licence / missing Sublicense etc.), You shall promptly pay any amounts due and You shall cover Our costs which arose in connection with such audit. You shall also provide Us with all assistance We reasonably request from You so We can effectively enforce Our rights in case of their breach by a third person who obtained the Product from / through You, without charging Us any costs.

## **5. PRICE AND PAYMENTS**

- 5.1. Prices. The prices of License to the Products stated in the offer on Our websites exclude VAT and other applicable taxes and charges. The price including all taxes and charges will be shown to You once You proceed to Paddle Platform.
- 5.2. Payment to Paddle Platform. You shall pay the price for the License directly to Paddle Platform in line with their terms and conditions. To be sure, We shall not deal with any requests for refunds and are not obliged to pay any refunds to You.
- 5.3. Discounts. We may, at Our sole discretion, offer the Licenses to the Products under discounted prices, e.g. for students, NGO's, cultural institutions or publisher houses. In case You fulfil the criteria specified in Our offer, You may send us an e-mail to our contact address with required details and documentation and We will assess Your request. We reserve a right to reject the discount request in case You do not fulfil the criteria according to Our assessment. If We assess Your request positively, We will provide You with promo code which You shall insert in the relevant field of the order form on the Paddle Platform. We shall not be liable for any issues caused by using incorrect promo code, technical or similar issues on the side of the Paddle Platform.

## 6. IMPORTANT LEGAL STUFF

- 6.1. Exclusion of Warranty. We provide You with the Product as is, without any warranty (whether express, implied, statutory or otherwise). We do not guarantee that the Product will fit for any particular purpose, be compatible or work with any software, system or other services, be accurate, complete or error free. If You spot any deficiency within the Product, notify Us in writing at latest within 7 days as of the commencement of License Term, We will scrutinize it and fix the deficiency. If You fail to notify us within the given deadline, We are not obliged to fix the deficiency. You expressly give up any other rights which could arise to You from defective performance.
- 6.2. Indemnification. If anything burdensome (like a legal claim, lawsuit, injury, etc.) happens in connection with breach of these Terms caused by You, You shall defend us and reimburse us for any damage We would suffer (including costs of legal representation, court or other proceedings, license fees, settlement fees etc).
- 6.3. Exclusion of liability. We shall not be liable for any direct or indirect damage that could arise as a result or in relation to the use of the Products or these Terms, including consequential, incidental, exemplary, special, enhanced or punitive damages, increased costs, loss of business, revenues or profits etc. In case We would anyway be held liable for any damages, our obligation to compensate them is limited up to CZK 2 000 in total. You expressly waive the right to compensation for damages above this amount.
- 6.4. No liability for Paddle Platform. We shall not be liable for any damage whatsoever which arise to You as a result of use of Paddle Platform, the technical or issues on the Paddle Platform, and We shall not be liable to pay You any refund whatsoever in connection with payments etc. towards Paddle Platform. You shall contact Paddle Platform directly if any issue arises. We are only in direct relation with You as concerns Your use of the Products.
- 6.5. Consumers. The provisions in this Article are not intended to deprive You of any consumer rights, if You qualify as a consumer under applicable laws. The provisions of this Article apply to consumers only to the extent allowed by applicable consumer laws.
- 6.6. Consent of consumers with provision of the Product before the period of 14 days for withdrawal. You hereby agree that You want the Products to be made available to You shortly after the payment of the price, i.e. long before the end of 14 days period which is granted to consumers from the EU for withdrawal (i.e. immediate termination) from the Agreement. This consent means You cannot exercise Your right to withdraw from the Agreement in 14 days period after conclusion of the Agreement (but You will have the Products available earlier).
- 6.7. Refunds. As You can order **License for Trial Fonts** for free before You purchase the appropriate License for intended use of the Product, We do not offer any refunds. The payments shall be managed by Paddle Platform. If you anyway feel that you are entitled for any kind of refund



according to applicable laws, please inform Us on our contact e-mail ([oomtype@gmail.com](mailto:oomtype@gmail.com)) and We will handle Your request individually.

## **7. FINAL PROVISIONS**

- 7.1. Applicable laws and jurisdiction. These Terms and all legal relations arising from or related to them are governed by the laws of the Czech Republic with the exclusion of rules on conflict of law. The disputes shall be settled amicably first, and if this does not work, they shall be decided by the courts of the Czech Republic which have jurisdiction according to Our registered office.
- 7.2. Communication. We will communicate together preferably in electronical form, and “in writing” or “written” form also means an e-mail with simple electronic signature.
- 7.3. Salvation Clause. If any provision of this agreement turns out as invalid, null, void, or unenforceable, the parties agree to replace such provision with valid, effective, and enforceable provision of the same commercial and legal significance within 14 days from the delivery of the written request of the other party.
- 7.4. Congratulations! You nearly finished reading the whole license agreement. As a bonus for your effort, you receive a non-exclusive license for a product created by Us for free under the following link: [Gift](#).
- 7.5. Term. Our legal relationship under these Terms lasts until the expiry / termination of the license term of Your last existing License.
- 7.6. Surviving Terms. The rights and obligation that, by their nature, should survive termination or expiration of the legal relationship between You and Us on the basis of these Terms, will survive any expiration or termination.
